Conservation Operations Report Projections for project completion have been significantly impacted by COVID19, with government offices shut and tourism affected. An increase in poaching is not yet evident from our site, but is a concern, as are the long-term impacts of global recession on the smaller organizations Rainforest Trust works with. We are working with partners on no-cost extensions; projects will be delayed.
